CALL FOR PROPOSALS FOR CONSTRUCTION OF MASONRY WATER TANKS FOR ILINGONI ROCK CATCHMENT IN KIBWEZI WEST CONSTITUENCY, MAKUENI COUNTY, KENYA

1. Introduction

Fadhili Trust is a Christian organization dedicated to working through partnerships to design, promote, and implement innovative and sustainable projects to transform rural communities holistically. One of the primary areas of focus for Fadhili Trust is Kibwezi West in Makueni County, an arid and semi-arid region where water scarcity significantly impacts the local population. In response to the challenge, this project has been initiated to provide a reliable source of water for domestic use, directly addressing the needs of the community.

This project aligns with the Sustainable Development Goals (SDGs), particularly Goal 6, which emphasizes the importance of clean water and sanitation. By facilitating access to water, the project not only enhances the quality of life for residents but also supports broader initiatives for sustainable development and community resilience.

2. Purpose for consultancy

Fadhili Trust is seeking a competent company to provide the services of construction of a 225m³ masonry water tank at Ilingoni rock catchment in Kalungu Sub-Location, Kibwezi West Sub-County, Makueni County, Kenya.

3. Scope of Work

The Contract to be established is for the construction of one masonry water tank of capacity 225m³ at Ilingoni rock catchment in Kalungu, Kibwezi West Sub-County, Makueni County, Kenya. The masonry water tank will store harvested rainwater from an existing rock catchment system. The water tank shall be interconnected to other existing tank in the vicinity.

The project site is located at E 0381047, N 974121 off Mombasa Road east of Kibarani in Mbui Nzau Area. Access to the site from Makindu Town is through Mombasa Road driving to the left turn off the exit to join the road that leads to Mbui Nzau Market. Once on this road drive 4.9 kilometres past the SGR railway to the project site within Mbui Nzau area.

4. Terms of Reference

The specific tasks are indicated on the **detailed Bill of Quantities (BoQs)** and will include but are not limited to the following:

- Mobilization of all plant, materials, equipment, and personnel to the project area.
- Construction of a 225m³ masonry water storage tank.
- Testing of the water tanks.
- · Interconnection with existing tank.

Deliverables

Fully finished, constructed and tested masonry water tank of 225m³.

5. Indicative Schedule of Activities

The prospective contractor shall submit a comprehensive work schedule in a Gantt chart format and a technical methodology proposal.

The work schedule shall include setting up the base camp, mobilization of materials and personnel. It will also construction of the water tank, testing and interconnection with existing ones. This schedule shall be checked and approved by the Supervisor. The methodology encompasses on how the whole exercise will be undertaken citing technical specifications.

6. Qualifications, Experience, and Skills

The following skills are expected in the team at a minimum:

a) The project Manager

The project Manager/ engineer should have a BSc. in civil/water engineering or equivalent technical qualification with over 3 years in an active water works construction environment. The Project Manager should have at least 7 years of experience in construction, management and operation of water projects. Registration with relevant professional bodies (EBK and IEK).

b) Foreman

The foreman should have relevant technical qualifications such as at least a Diploma in water and/or Civil engineering or related qualifications. At least five years of experience in the construction of water works. The foreman with conduct day-to-day quality check, control and provide technical support. Registration with the relevant professional bodies including NCA as site agent/supervisor is mandatory.

c) Artisan

The artisan should have relevant technical qualifications such as at least a certificate in water and/or Civil engineering or related qualifications or Grade Test certificate. At least five years of experience in the construction of water works.

7. Terms of Payment

Payments to the contractor will be made in milestones as follows:

- 50% will paid after mobilization of equipment, technical staff, and signing of the contract.
- 30 % after satisfactory completion of tank sub structure, super structure, roof slab, plastering and plumbing works.
- 15% upon completion of all the tasks as per this TOR, testing, and project completion.
- 5% to be held as retention for 3 months to take care of any defects.

8. Application Criteria

Interested contractors should submit a detailed proposal capturing the following:

Mandatory requirements:

- · A Copy of the Certificate of Incorporation/Registration,
- A copy of the Current Tax Compliance certificate from Kenya Revenue Authority
- · Copy of Valid and current Business Permit,
- · Bid Bond

Technical Requirements:

- A copy of CR12 Form and a copy of the National Construction Authority (NCA 8) registration Certificate for at least Class 8 which must be in the waterworks Category. They should be attached as Annexes.
- Company Experience: Evidence of Company proven experience with details of contracts and references for works undertaken similar water works (Attach at least 2 completed contracts with certificate of completion)
- Proven track record, technical expertise and experience. Provide a brief overview of how the
 proposed candidates meet the qualifications, experience, and skills requirements. Attached CVs and
 Certificates of the project manager, foreman, and artisan as annexes.
- A three (3-) month bank statement up to December 2024.
- A costed BOQ on company letterhead and signed by the Managing Director
- · A detailed work plan with a Gantt chart
- A technical proposal detailing how the Contractor will undertake the works
